The 2000 meeting in Lake Tahoe is complete (except for the Proceedings) and was successful. Hopefully a complete accounting will be available for this meeting. It would be very helpful if I could obtain the final accounting to include the averages in the Symposia handbook.

The 2001 meeting in Colorado Springs, CO is progressing well. Ron Bihler and I have had several phone conversations and work appears to be progressing well. The rates for the symposium will be \$113.00 for single/double. These rates will be available four days before and after the meeting dates. Registration rates for this symposium have to be established at this BOD meeting. Ron should publish and mail the advance registration packet by the first of February.

The 2002 meeting will be held at Marriott's Grand Hotel at Point Clear, Alabama (near Mobile, Alabama). This meeting will be hosted by the Southeast section and chaired by Gene Nelson. The dates for this meeting will be May 28 thru June 1, 2002. The hotel is located on Mobile Bay and is a very beautiful resort. The rates for this meeting have been established at \$129.00 for single/double. These rates are available three days before and after the meeting dates. Gene already has several commitments for committee positions. Exhibitor rates for this symposium have to be set at this BOD meeting.

The Great Lakes section will serve as our host for the 2003 meeting and Scott Bankroff was approved as the chair. The meeting will be held at the Sheraton Cleveland City Centre hotel in downtown Cleveland, Ohio. The dates for this meeting will be June 17 thru June 21 and the rates should not exceed \$124.00 for single/double. The location of this hotel is very convenient an within walking distance of many city attractions.

The Northeast section is actively seeking a site for the 2004 meeting and we hope to have a completed contract before the June '01 BOD meeting. Dan Wilt is the driving force behind this effort and was approved as the chair for this symposium.

If this BOD is considering any changes to the current symposium format, they should be discussed and recommendations made at this meeting. Things that affect the hotel and dates contracted for should only be considered for the '04 and '05 symposiums. Things that affect our program only, can be changed at almost any time. I welcome any comments.
